#### **What are Cookies?**

A cookie is a small file of letters and numbers downloaded and stored on your computer's hard disk when you visit a website. They allow us to distinguish you from other users of the website as each cookie is unique to your web browser. This helps us to provide you with a better browsing experience and to improve our website. Cookies are not programs and cannot be executed as code, deliver viruses or install malware.
